

## Instructions to authors

The Società Siciliana di Scienze Naturali publishes *Il Naturalista Siciliano*, journal distributed in Italy and outside the country, which contains original articles connected with natural history research in the Mediterranean area, articles of general interest (methodologies, reviews, etc.) and book reviews. Papers not exceeding two printed pages are published as Short notes. Access to publication is not restricted to members of the Società Siciliana di Scienze Naturali. *Il Naturalista Siciliano* has a publication ethics and publication malpractice statement. Manuscripts should be sent to the Editor-in-chief (e-mail: [bruno.massa@unipa.it](mailto:bruno.massa@unipa.it)); papers prepared in accordance with the Instructions to authors will be examined within two months by the Editorial board. Scientific papers, reviews and short notes are published once they are deemed acceptable after a thorough process of peer-review. The decision (acceptance, request for improvement, refusal) will be notified to the first author together with other relevant information (expected date of publication, specification of charges for the authors, etc.) within four months after the deposit of the manuscript.

The authors should conform to the arrangement of articles published in the most recent issues of *Il Naturalista Siciliano*. Each article should include: NAME(S) of AUTHOR(S), TITLE, SUMMARY in the language of the paper followed by another SUMMARY in Italian or in English (the second summary should begin with a translation of the title in italics). *Parole chiave* and *Key words* must follow respectively RIASSUNTO and SUMMARY. The chapters titles should be written in capital (INTRODUCTION, MATERIALS AND METHODS, RESULTS, BIBLIOGRAPHY), the paragraphs titles in italics. The bibliography should list references in alphabetical order under the (first) author's name, and chronologically for the same author, as follows:

RUGGIERI G., 1978. Una trasgressione del Pleistocene inferiore della Sicilia occidentale. *Naturalista sicil.*, Palermo, 2: 159-171.

FIORI A., 1928. Nuova flora analitica d'Italia. *Ricci*, Firenze.

The address(es) of the author(s) should appear at the end of the article. Tables should be clearly typed, and contain a legend. Illustrations should be numbered consecutively, and the legend written at the end of the paper. The author should mark in the margin of the manuscript the approximate place where tables and figures have to be inserted in the text. Short notes are printed in 8-point and should comprise: NAME(S) of the AUTHOR(S), TITLE in the language of the text followed by a translation of the title in Italian or in English, text and BIBLIOGRAPHY as in the articles, address(es) of the author(s).

The authors are requested to send back the corrected proof-sheets within two weeks; the Editorial board will correct the revise. When returning the proofs the authors should communicate the number of requested reprints and to whom the eventual invoice should be made out. Additionally, a pdf format of the paper will be provided to authors.

A page charge of Euro 20.00 (nonmembers of the Società) and Euro 15.00 (members) per printed page is assessed. Authors are invited to agree upon costs of particular tables or colour figures directly with the typography.
